CM APPL.80426/2025 (u/O 22 Rule 4 CPC moved by appellant for bringing on record the LR's of R-1/Ramesh Chandra Kapoor) & CM No.80247/2025 (delay of 31 days)

1. The office report shows that proposed LR's of deceased respondent No.1 could not be served due to insufficient address.
2. On appellant's filing PF and fresh/complete address within four weeks, issue notice to non-applicants including the proposed LR's of deceased respondent No.1, by all permissible modes including electronic mode, returnable on 18.08.2026.

4. Respondent no.1(b) submits that the address of respondent no.1(a) and 1(b) is : **A-180, 1st floor, Lajpat Nagar-I, New Delhi-110024.**
5. Notice need not be issued to the proposed LRs as mentioned in para 2 above.
6. In view of the above, delay of 31 days in moving the application under Order XXII, rule 4, CPC is condoned and the following LRs are brought on record : 1(a) - Smt. Renu Kapoor (widow) and 1(b) - Mr. Ankur Kapoor (son).
7. Notice as directed in para 2 above, need not issue. Date of 18.08.2026 stands cancelled.
