Ms. Aliza Alam, learned counsel appearing for GNCTD in W.P.(C) 1698/2010 seeks and is granted four weeks further time to file a comprehensive affidavit as directed in un-numbered para 3 of the order dated 24.05.2023. Advance copy whereof be furnished to counsel for petitioner and counsel for respondent as well who may be affected by the outcome of the writ petition.

2. In W.P.(C) 8973/2017 Mr. Nandrajog, learned senior counsel appearing for the petitioner has invited attention of this Court to the affidavit filed by the respondent no.1 styled as counter affidavit in
