ORDER

1. This hearing has been done through hybrid mode.



2. These are a batch of land acquisition matters which are to be heard, upon being remanded by the Supreme Court.
3. *Vide* orders dated 25th February, 2026, 7th May, 2026 and 10th July, 2026, the Court had finalised the **Blank Template** seeking details in each of the matters, which was to be filed by the Id. Counsels for the parties.
4. Some of the Id. Counsel for the Petitioners submit that they have filed their duly filled templates, and some of the Petitioners are yet to file their templates.
5. The Land Acquisition Collector (LAC) has not filed the templates in most matters.
6. Accordingly, let the parties, who have not filed the blank templates do the needful within a period of four weeks.
7. In the cases where templates are filed, if there is any revision or modification is to be done, the same is permitted.
8. In whichever cases the LAC and the Delhi Development Authority (DDA) have not filed their additional affidavits after the remand by the Supreme Court, they are permitted to do so within a period of four weeks. Rejoinders, if any, be filed within a period of four weeks thereafter.
9. The LAC shall file its reply in all these matters, if not filed yet, within a period of four weeks.
10. The delay in filing counter-affidavits or any other pleadings including additional affidavits is condoned. Let all the pleadings be brought on record.
11. Today, the Court has been handed over a copy of the order dated 22nd July, 2026 passed by the Supreme Court in a batch of matters pertaining to land acquisition cases, including **Miscellaneous Application No. 1532/2025 in C.A. No. 146 of 2023 and other connected matters** wherein the following



directions have been issued:

“3. This batch of cases, comprising Civil Appeals, Special Leave Petitions, Contempt Petitions, Miscellaneous Applications, Review Petitions, Curative Petition(s), etc. pertains to acquisition of lands in the NCT of Delhi. Despite the large number of such cases decided through three decisions rendered by a Coordinate Bench, of which one of us (Surya Kant, J., as he then was) was a member, i.e., (i) *State (NCT of Delhi) v. K.L. Rathi Steels Ltd.*, (2024) 7 SCC 315, (ii) *State (NCT of Delhi) v. BSK Realtors LLP*, (2024) 7 SCC 370, and, (iii) *DDA v. Tejpal*, (2024) 7 SCC 433, hundreds of cases, i.e., the instant matters, still await adjudication in terms of those decisions.

4. It appears to us that the appropriate recourse would be to remit these cases to the High Court of Delhi, with a request to Hon’ble the Chief Justice of the High Court to constitute a dedicated Division Bench, which shall take up these cases on day to-day basis. The adjudication therein, it goes without saying, would be strictly in terms of the law laid down in the above-cited judgements.

10. Due to the commonality in issues, those cases are taken on board. Mr. Poddar undertakes to inform the learned counsel for the parties in such cases about the passing of this order to enable such counsel to also file their objection, if any, with him.

11. The matters, which after scrutiny of the compilation to be submitted by Mr. Poddar are identified to pertain to issues settled through the three above-cited judgements, stand disposed of and remitted to the High Court through a detailed signed order/judgement of even date. The remaining cases, if any, shall be listed after taking appropriate directions from the Chief Justice of India, on the administrative



side.”

12. Ld. Counsels also submit that after the order dated 22nd July, 2026, a list of cases/ applications have been placed before the Supreme Court and some further orders are awaited after the filing of said list.

13. Considering the directions passed by the Supreme Court which have been extracted above, list these matters for consideration before Court on 5th November, 2026.

14. In ***W.P.(C) 4192/2015, W.P.(C) 2481/2016 and W.P.(C) 4771/2016*** the registry to ensure that the appropriate cause title is reflected, as amended memo of parties is stated to have been filed in these matters.

15. All Ld. Counsel for parties are permitted to obtain the electronic record from the Court Registry in order to prepare and file their written submissions.
