CM 6/2025 & CM 8/2025 (Exemption from filing certified/original and true typed copies of documents having sufficient left hand margin)

1. The present are applications under Section 151 of the Code of Civil Procedure, 1908 (“CPC”), on behalf of the petitioner, seeking exemption from filing certified/original and true typed copies of documents having sufficient left hand margin.
2. Exemption is granted, subject to all just exceptions.
3. Petitioner shall file certified/original and true typed copies of documents having sufficient left hand margin, on which the petitioner may seek to place reliance, before the next date of hearing.
4. Accordingly, the present applications are disposed of.

CM 5/2025 & CM 7/2025 (seeking summoning of the record of trademark from the office of respondent)

5. The present applications have been filed on behalf of the petitioner seeking summoning of the complete record of trademark “RAJMOTI (DEVICE)” registered under no. 289101 in Class 29 and no. 791444 in Class 29 from the office of respondent.
6. The respondent Registrar of Trademarks is directed to place on record all the requisite documents.
7. With the aforesaid directions the present applications are disposed of.

8. W.P.(C)-IPD 2/2025 has been filed seeking direction to respondent no.1 for renewing the trademark registration bearing no. 289101 in Class 29 or direction to the respondent for disposing of the Interlocutory Petition filed by the petitioner on 24th January, 2020 with an opportunity for hearing to the petitioner.



9. W.P.(C)-IPD 3/2025 has been filed seeking to quash the status of the petitioner's registered trademark RAJMOTI (DEVICE) bearing registration no. 791444 in Class 29 dated 16th February, 1998, which is currently shown as 'Rectification Filed'.
10. Further, the petitioner seeks direction to the respondent to renew the said trademark registration of the petitioner and direct the respondent to correct the status thereof as 'Registered'.
11. Issue notice. Notice is accepted by learned counsel appearing for the respondent, who raises objection as regards the territorial jurisdiction of this Court. He submits that the mark in question was registered in Ahmedabad, Gujarat and that the application for renewal was also filed in Ahmedabad, Gujarat. Therefore, he submits that the present petitions are not maintainable.
12. Let reply be filed within a period of four weeks.
13. Rejoinder thereto, if any, be filed within two weeks, thereafter.
14. Re-notify on 25th April, 2025.
