1. This hearing has been done through hybrid mode.
2. In these matters, *vide* order dated 11<sup>th</sup> November, 2025, the predecessor Bench of this Court had directed as under:

16. Ms. Smita Maan, counsel appearing for petitioner and Ms Malvika Kapila appearing for respondent/ Delhi Development Authority (‘DDA’) undertake to prepare, with mutual consultation, a ‘Blank Template’ containing an optimum format to be used by parties/counsel subsequently to populate with material facts, which according to them are necessary for the purpose of consideration and deciding the issue.

17. *Let the aforesaid preparation of the Blank Template be completed within a period of eight weeks from today and a copy provided to the Court Master, which after approval of this Court, be shared with counsel for the parties in each of these matters, for them to populate the Blank Template with relevant facts of their respective cases. This process is being undertaken only to provide a convenient summary to the Court and the parties, and will not estop any party from raising any submission.*

18. *Re-notify before this Court on 25<sup>th</sup>*



*February, 2026...”*

3. In terms of the above order, Ms. Smita Mann, Id. Counsel for the Petitioner and Ms. Malvika Kapila, Id. Counsel for the Respondent/Delhi Development Authority (*hereinafter*, ‘DDA’) were directed to prepare a ‘**Blank Template**’, after mutual consultation, so that all the basic facts in each of these matters can be compiled and understood in an easy manner, at the time of final hearing.

4. Today, both the Id. Counsels have placed before the Court their respective ‘**Blank Template**’.

5. The Court has heard Ms. Smita Mann, Id. Counsel as also Mr. Poddar, Id. Sr. Counsel and Ms. Malvika, Id. Counsel. The Court has also perused the **Blank Templates** filed by them.

6. After considering the respective suggestions from the Id. Counsels appearing on behalf of the parties, the Court has finalised the ‘**Blank Template**’. The final copy of the template shall be kept in Court and shall be made available to the respective Counsels for being collected by them.

7. In each of these matters, the templates shall be duly filled up and filed by Id. Counsels for the Petitioners and Id. Counsels for the Land Acquisition Collector (*hereinafter*, ‘LAC’) and DDA separately.

8. Thus, the timeline for completion of all necessary formalities in these cases shall be as under:

- (i) Completion of pleadings in all the matters, including in the I.As. and filing of additional affidavits and any further rejoinders thereto shall be done by 10<sup>th</sup> April, 2026;
- (ii) Filing of duly filled up templates by Id. Counsels for the Petitioners, the LAC & DDA shall be completed by 30<sup>th</sup> April, 2026.
