Amended plaint is already taken on record.

At this stage, learned counsel for the plaintiff undertakes to pay previous cost of Rs.20,000/- imposed vide order dated 13.09.2024 to learned counsel for the defendant no.1&2 digitally within three days. Let needful be done as stated.

As per office note, Written Statement to the amended plaint filed by defendant no.1 is on record. It is stated by learned counsel for the defendant no.1&2 that prior to the amendment of plaint, Affidavit of Admission/Denial of the documents has already been filed by defendant no.1&2. However, the defendant no.2 had expired on 17.09.2024 and hence, Written Statement to the amended plaint has been filed by defendant no.1. Copy of the same already received by the plaintiff. The defendant no.1 has also filed documents in the present matter alongwith the Written Statement earlier filed.



So, the plaintiff is directed to file Replication alongwith Affidavit of Admission/Denial of the documents within stipulated period as prescribed by law with copy to the opposite side.

The plaintiff is also directed to do the needful with regard to impleadment of LR of deceased defendant no.2, as per law.

Further, Written Statement alongwith Affidavit of Admission/ Denial of the documents to the amended plaint filed by defendnat no.5&6 is also on record. Copy of the same already received by the plaintiff.

So, the plaintiff is directed to file Replication to the same within stipulated period as prescribed by law with copy to the opposite side.

The plaintiff is also directed to file soft copy as well as physical copy of the Joint Schedule of the documents at least two weeks before the next date of hearing with copy to the opposite side.

The parties are directed to file physical copy of the documents of which e-copy already filed on record, if not filed earlier, before the next date of hearing.

Re-notify the matter for completion of pleadings/markings of exhibits to the documents on 13.12.2024.
