**I.A. No.2531/2021 (under Section 151 CPC – by plaintiff
for modification of order dated 08/01/2021)**

1. No separate reply to the application has been filed by either of the defendants.

I.A. No. 9710/2021 (under Order VI Rule 17 r/w Section 151 CPC moved by the plaintiff for amendment of plaint)

1. Reply to the captioned IA already filed on behalf of the defendants no.1 and 2 and defendants no.5 and 6.
2. Ld. Counsel for plaintiff already submitted that plaintiff did not wish to file rejoinder to the replies of defendant no. 1 & 2 and defendant no. 5 & 6.
3. Ld. Counsel for plaintiff has submitted that fresh address



of the defendant no.4 yet not been traced out and he needs some more time for furnishing fresh address of the defendant no.4. Let the same be filed accordingly.

4. On furnishing fresh address of the defendant no.4, issue fresh notice of the captioned IA to the defendant no.4 through all permissible modes.
5. Re-notify for completion of service and completion of pleadings and further proceedings on **24th April, 2023.**

I.A. No.8513/2022 (u/O XXXIX Rules 1 & 2 CPC by plaintiff)

1. Ld. Counsel for defendants no.1 and 2 submits that he has filed reply to captioned IA vide dairy no.1817594/2022. As per office noting, the aforesaid reply is under objection. Let appropriate steps be taken as per law.
2. Ld. Counsel for plaintiff submits that copy of captioned IA could not be supplied to Ld. Counsel for defendants no.5 and 6 and seeks some more time for supply the same. Let the same be supplied within 03 days.
3. After receiving copy of the application, the defendants no.5 and 6 may file reply to the captioned IA within two weeks thereafter with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.
4. No reply to the captioned IA filed on behalf of defendant no.3.
5. The defendant no. 3 may file reply to the captioned IA within four weeks with advance copy to opposite party, who may file rejoinder within two weeks thereafter.
6. On furnishing fresh address of the defendant no.4, issue fresh notice of the captioned IA to the defendant no.4 through all permissible modes.



7. Re-notify the captioned IA for completion of service, completion of pleadings and further proceedings on 24th April, 2023.

CS(OS) 15/2021 & I.A.No.306/2021 (u/O XXXIX Rule 1 & 2 CPC)

1. As per office noting, nothing fresh has been filed.
2. An application for amendment of plaint is pending.
3. On furnishing fresh address of the defendant no.4, issue fresh summons of suit and notice of the captioned IA to the defendant no.4 through all permissible modes.
4. Let the pleadings be completed as per law.
5. Re-notify the present matter for completion of service, completion of pleadings and further proceedings on 24th April, 2023.
