1. Learned Amicus Curiae, Ms.Akanksha Kaul and Ms.Nandita Rao, Advocate have handed over their report of inspection dated 27th August, 2024. The same is taken on record.
2. Central Bureau of Investigation ('CBI') has handed over its status report in a sealed cover. The same is directed to be re-sealed.
3. From the inspection report filed by learned Amicus Curiae, certain doubts with regard to finances of Rohini Ashram have been raised.
4. Learned counsel for Rohini Ashram prays for and is permitted to file a response to the inspection report within four weeks.
5. Since doubt has also been raised with regard to age of some of the inmates of Rohini as well as Palam Ashram, CBI is directed to verify the age of the inmates and file a fresh status report before the next date of hearing.
6. The Petitioner in W.P.(C) 2004/2020 and the Respondent in W.P.(CRL) 221/2024 are permitted to file additional affidavits.
7. Mr.Amol Kokane, Advocate has volunteered some information with regard to management and control of Rohini Ashram. The said information has been shared with the Investigating Officer, CBI, who, in turn, is directed to verify the same. List the matter on 2nd December, 2024.
