1. Let an additional affidavit be filed by the Delhi Development Authority as also the Land Acquisition Collector in all these petitions within eight weeks.
2. The additional affidavits to be filed under this order will not only address the issue which has been culled out in the judgments of the Hon'ble Supreme Court in the cases of **DDA vs. Tejpal & Ors., (2024) 7 SCC 433; Govt. of NCT of Delhi & Anr. vs. BSK Realtors LLP & Anr., (2024) 7 SCC 370** and **Govt. of NCT of Delhi vs. K.L. Rathi Steels Ltd. & Ors., (2024) 7 SCC 315**, but it will be open to these respondents to take all other pleas as well.
3. Reply to such affidavits shall also be filed by the non-applicant/petitioners within eight weeks. Rejoinder thereto, if any, be filed within three weeks thereafter.
4. We request the learned counsel representing the Delhi Development Authority to prepare a chart categorising all these matters in three bunches covered by the judgments of the Hon'ble Supreme Court in cases (1) **DDA vs. Tejpal (supra)**, (2) **Govt. of NCT of Delhi & Anr. vs. BSK Realtors LLP**



& Anr., (2024) 7 SCC 370 and (3) Govt. of NCT of Delhi vs. K.L. Rath Steel Ltd. & Ors., (2024) 7 SCC 315.

5. We also request that while preparing the chart, the categories of cases as mentioned in these three judgments namely **DDA vs. Tejpal (supra)**, **Govt. of NCT of Delhi & Anr. vs. BSK Realtors LLP & Anr. (supra)** and **Govt. of NCT of Delhi vs. K.L. Rath Steel Ltd. & Ors. (supra)** of the Hon'ble Supreme Court shall also be mentioned. We request the learned counsel for the petitioners to cooperate with the learned counsel representing the Delhi Development Authority in preparation of the chart. We make it clear that we have requested for preparation of chart only to facilitate the hearing of these matters.

6. We further request learned counsel representing the Delhi Development Authority that once the chart is ready, the same shall be submitted to the Registry, which shall list the matters on the next date in terms of the said chart in three categories as provided above.

7. An additional affidavit shall also be filed by the Land Acquisition Collector giving the details of the payments made and taking all other pleas.

8. List on 07.08.2025 for filing of aforesaid chart, additional affidavits and hearing on application for condonation of delay.
