1. This hearing has been done through hybrid mode.
2. On the previous date of hearing *i.e.*, 25th February, 2026, the Court had finalised the '**Blank Template**' seeking details in each of the matters which was to be filed by the Id. Counsels for the parties in terms of the order dated 11th November, 2025, and had fixed timelines for the parties to fill the '**Blank templates**' and file the same, as also file the additional affidavits in the following terms:

*"[...]*

*6. After considering the respective suggestions from the Id. Counsels appearing on behalf of the parties, the Court has finalised the '**Blank Template**'. The final copy of the template shall be kept in Court and shall be made available to the respective Counsels for being collected by them.*

***7. In each of these matters, the templates shall be duly filled up and filed by Id. Counsels for the Petitioners and Id. Counsels for the Land Acquisition Collector (hereinafter, 'LAC') and DDA separately.***



*8. Thus, the timeline for completion of all necessary formalities in these*

*cases shall be as under:*

*(i) Completion of pleadings in all the matters, including in the I.As. and filing of additional affidavits and any further rejoinders thereto*

*shall be done by 10th April, 2026;*

*(ii) Filing of duly filled up templates by Id. Counsels for the Petitioners, the LAC & DDA shall be completed by 30th April, 2026.*

*9. Parties are directed to appear before the Registrar for completion of pleadings as per the following schedule:*

**XXX**

**10. It is made clear that if the additional affidavits and pleadings are not filed by all parties by 10th April, 2026, the right shall stand automatically closed and there shall be no further opportunity to file the same....”**

3. Today, the templates which were to be filed by the Id. Counsels for the parties have not been placed on record in some matters.

4. In some matters, the Petitioners have filed their templates. However, templates on behalf of the Land Acquisition Collector (*hereinafter*, ‘LAC’) and the Delhi Development Authority (*hereinafter*, ‘DDA’) have not been filed.

5. Further, Id. Senior Counsels in some of the matters submit that there are issues, which are unique to certain cases, which may not be covered in the templates.

6. If so, the Id. Counsels for the parties in such cases, are permitted to file an additional one page note along with the templates.



7. All the templates shall be brought on record.
8. Considering the nature of the batch of matters, all the Id. Counsels for the parties shall endeavour to appear physically in the Court and not virtually.
9. The Id. Counsels for the parties shall appear before the Joint Registrar for completing the filing of duly filled up templates, additional affidavits, if any, and the necessary formalities.
