1. On 29.08.2023, parties were directed to file written synopsis, (not exceeding three pages each), along with compilations of judgments in LA APP. 452/2009, LA APP. 557/2009 & LA APP.84/2021. It was also directed that two separate convenience compilation be prepared— one by appellants in LA APP. 452/2009 & LA APP. 557/2009 and the other by appellant in LA APP.84/2021.
2. MCD has filed its written synopsis within the time granted by the court and the same is on record.



3. Despite a period of more than one year having been passed, no written statements (three pages) along with convenience compilation and list of judgment has been filed by the appellant- India Export House Pvt. Ltd. It has been observed in the previous orders that the written statement (three pages) to be filed by the appellants in LA APP.452/2009 & LA APP.557/2009 is dependent on the convenience compilation that will be filed by the appellant- India Export House Pvt. Ltd.
4. Today, learned counsel appearing for India Export House Pvt. Ltd. submits that the same has been filed electronically and gave the two diary numbers i.e. 5604599/2024 & 5604619/2024. On checking with the Registry, it transpired that a list of judgements (without cause title) have been filed twice through these diary numbers. Let the objection(s) be removed before the next date. The list of judgments is taken on record.
5. Learned counsel for India Export House Pvt Ltd. submits that she has supplied advance copy of convenience compilation to all the parties via e-mail. Learned counsel further submits that vide Order dated 29.08.2023 the Hon'ble Court has directed the appellant- India Export House Pvt. Ltd. to supply the written synopsis along with the convenience compilation to the appellants in LA APP.452/2009 & LA APP.557/2009 and there is no order to file the same. Let learned counsel for the appellants go through the Order dated 29.08.2023 and subsequent order thoroughly.



6. Learned counsel for the parties present here submits that they have not received any convenience compilation till date from India Export House Pvt. Ltd.
7. Let India Export House Pvt. Ltd. file their written synopsis and convenience compilation within five weeks failing which Registry is directed to take the same on record Subject to payment of costs of Rs.15,000/- to be deposited with the Secretary, Delhi High Court Legal Services Committee.
8. In case written synopsis (within three pages) and convenience compilation are not filed by the appellant-India Export House Pvt. Ltd. within the time now granted with advance copy to learned counsel for the appellants in LA APP.84/2021, the matter will be listed before the Hon'ble Court on the next date.
9. Re-notify on 01.05.2025.
