2. The revisionist has assailed judgments and orders dated 22.05.2025 of learned Additional Sessions Judge, whereby his convictions under Section 138 Negotiable Instruments Act and sentence of 18 months imprisonment with fine of Rs. 2,00,000/- in each case was upheld.

3. Learned counsel for respondent appearing on advance intimation accepts notice.

It is informed by both sides that after dismissal of appeal, the revisionist was taken into custody and subsequently parties compromised the disputes, whereby the present respondent agreed to accept a total sum of Rs. 5,00,000/- from petitioner towards full and final settlement of all three cases and accordingly, they jointly request for setting aside the appellate order and the conviction as well as sentence.
