**I.A. No. 15089/2025 on behalf of the plaintiffs seeking
condonation of delay of 13 days in filing the replication to the

1. Issue notice. Notice accepted by Id. Counsel for defendant no. 1 who submits that if the delay is to be condoned, same should be subject to a reasonable cost.
2. For the reasons stated in the application, application is allowed subject to cost of Rs. 2000/-, to be paid to defendant no. 1 through his counsel within four weeks failing which further cost shall be imposed. Delay stands condoned. Replication to the written statement of defendant no. 1 is taken on record. IA stands disposed off.
