As per office note, List of Witnesses has not been filed by the parties till date. Further, Evidence Affidavit has also not been filed by the plaintiff.

At this stage, it is stated by learned counsel for the plaintiff that he has filed List of Witnesses and Evidence Affidavit two days back vide diary no.E-5123079/2024.

It be noted that issues were framed in the present matter on 09.04.2024. Further, vide order dated 14.05.2024, both parties were directed to file List of Witnesses and plaintiff was also directed to file Evidence Affidavit. Hence, the plaintiff had ample time to file List of Witnesses and Evidence Affidavit but the same was filed by the plaintiff only two days back for which no plausible explanation is furnished by learned counsel for the plaintiff. So, cost of Rs.4000/- is imposed upon the plaintiff to be deposited with Delhi High Court Legal Services Committee and now last and final opportunity is granted to the plaintiff to take requisite steps to bring List of Witnesses and Evidence Affidavit on record. The



plaintiff is also directed to ensure that physical copy of said Evidence Affidavit of the witness is filed on record.

No List of Witnesses has also been filed by the defendant. None is present on behalf of the defendant today to explain in this regard despite repeated calls. So, cost of Rs.1000/- is imposed upon the defendant to be deposited with Delhi High Court Legal Services Committee and now, the last and final opportunity is granted to the to file List of Witnesses in the prescribed format within two weeks with copy to the opposite side.

The parties are directed to deposited the cost within two weeks and also file its proof of cost before the next date of hearing.

Re-notify the matter for PE on 18.03.2025.
