1. No reply has been filed till date. Perusal of the order dated 06.11.2025 reveals that notice was accepted by the plaintiff and four weeks' time was granted to file reply. Thereafter, in the interest of justice, a further two weeks' time was granted vide order dated 20.02.2026, making it clear that the same was a last and final opportunity.
2. Learned counsel for the plaintiff submits that the reply has been filed today. However, the office note and the official record do not reflect filing of any such reply.
3. Learned counsel for Defendant Nos. 1 to 3 submits that the right of the plaintiff to file reply be closed as despite sufficient opportunities, the



reply has not been brought on record.

4. No satisfactory explanation has been furnished by learned counsel for the plaintiff for the delay. In view of the conduct of the plaintiff, this Court is of the view that sufficient opportunity has already been granted.
5. Accordingly, the right of the plaintiff to file reply to the captioned IA is closed.

CS(OS) 50/2025:

6. As per office note, vakalatnama filed on behalf of Defendant No. 5 has been returned under objections. Let the same be placed on record after removal of objections.
7. As per office note, vakalatnama has been filed on behalf of Defendant Nos. 8 and 9, which is taken on record.
8. Vide order dated 20.02.2026, directions were issued for fresh summons to unserved defendants. However, as per office note, summons could not be issued due to failure on the part of the plaintiff to file process fee.
9. Accordingly, a cost of ₹5,000/- is imposed on the plaintiff, to be deposited with the Delhi High Court Bar Association. One further opportunity is granted. Let steps be taken within one week from today.
10. The matter is listed before the Hon'ble Court on 23.03.2026.
11. Let the matter be listed on the said date for further directions.
