1. Matters have been taken up today in terms of Minutes of the Meeting dated 12.02.2026 of the Hon'ble Case Flow Management Committee, High Court of Delhi.
2. By way of the above captioned Writ Petitions, the petitioner seeks quashing/setting aside of the Master circular, issued by the respondent/Reserve Bank of India and writing down of Additional Tier 1 Bonds by Yes Bank Limited, the "Yes Bank Ltd. Reconstruction Scheme" issued by UOI on 13.03.2020, quashing the right down of ATI bonds, and to further quash/set aside the purported communication dated 14.03.2020 issued by respondent/YBL and further directions.
3. Vide order dated 11.04.2022, the Hon'ble Court had directed the proceedings at hand to be stayed *sine die* owing to order dated 01.02.2022 passed by the Hon'ble Apex Court in TP(C) no. 968/2020 with liberty of the parties to move an appropriate step as and when the need so arises.
4. As per office note, court notice issued to the petitioner no. 1&2 received back 'served'; and that issued to respondent no. 1 to 3 received back 'served' in W.P.(C) 4522/2020.



5. Further, as per office note, court notice issued to the petitioner received back 'served'; and that issued to respondent no. 1,2&3 received back 'served' in W.P.(C) 4255/2021.

6. Further, as per office note, court notice issued to the petitioner received back 'served'; that issued to respondent no. 1,2&3 is awaited; and that issued to respondent no. 4 received back un-served with remarks 'no such person' in W.P.(C) 14430/2021.

7. Learned counsel for respondent no. 1/YES Bank Ltd. submits that the Hon'ble Supreme Court has reserved the matters for orders.

8. Matters may be placed before the Hon'ble Court on 24.07.2026, for further directions.
