1. Mr. Sanjay Yadav, respondent in person is present in Court.
2. Sub Inspector ("SI") Manmohan, Police Station, Kalindi Kunj is also present in Court.
3. Considering the submissions made before this Court that the petitioner has been abused and treated violently by the respondent, it is



directed that the respondent Mr. Sanjay Yadav shall neither visit the house of the petitioner nor her work place, as well as her parents' house. It is further directed that Mr. Sanjay Yadav, shall not be seen in a distance of 15 meters from the house of the petitioner or her work place or her parents' house.

4. SHO, Police Station, Kalindi Kunj is directed to ensure that a Beat Constable keeps a watch on the house of the petitioner. Further, if the Police ever finds that the respondent – Mr. Sanjay Yadav is seen within the vicinity of 15 meters of the petitioner's house or her work place or her parents' house, appropriate actions shall be taken against him.

5. Mr. Sanjay Yadav submits that he intends to resolve all the disputes with the petitioner.

6. Accordingly, with the consent of the parties, the matter is referred to Delhi High Court Mediation and Conciliation Center on 29th February, 2024, at 12:00 PM.

7. List before the Court on 10th April, 2024.

8. Mr. Abhinav Singh, learned counsel appearing for Delhi Police is directed to explain today's order to Mr. Sanjay Yadav who is present in Court. He shall also give the details of the Delhi High Court Mediation and Conciliation Center to Mr. Sanjay Yadav, so that he can appear there when the matter is listed.

9. Copy of this order be sent to the Delhi High Court Mediation and Conciliation Center forthwith.
