C.A. 392/2020 (for exemption from filing attested affidavit and court fee) in CO.PET. 204/2003

1. This application seeks exemption from the requirement of filing attested affidavits and court fee. Subject to attested affidavits and requisite court fee being filed within 72 hours of resumption of normal court work, exemption is granted for the present.

2. The application is allowed accordingly.

C.A. 391/2020 in CO.PET. 204/2003

1. Ms. Tara Ganju, learned Counsel for the applicant draws my attention to the order dated 2nd February, 2016, which requested that, should an objection be filed by M/s Ceylon Biscuits Pvt. Ltd., or any other party, the said objection be decided at the earliest. She submits that, despite more than four and a half years having passed since that date, the objections filed by M/s Ceylon Biscuits Pvt. Ltd. are still pending adjudication, as a result of which her client is unable to recover electricity and wheeling charges.

2. As there is no appearance on behalf of M/s Ceylon Biscuits Pvt. Ltd. Ms. Ganju submits that the only respondent who would be required to be heard in this matter would be the Official Liquidator and M/s Ceylon Biscuits Pvt. Ltd.

3. Though the Official Liquidator is represented, there is no appearance on behalf of M/s Ceylon Biscuits Pvt. Ltd.

4. Ms. Tara Ganju, learned Counsel for the applicant submits that, after the order passed by the Division Bench, certain other Counsel have appeared on behalf of M/s Ceylon Biscuits Pvt. Ltd. She submits that she would make inquiries to find out the Counsel who is representing the said party at present, as well as her/his email id and intimate the Court Master accordingly. On such intimation being given, let notice of this application be issued at the said email id. Let affidavit/proof of service be placed on record before the next date of

hearing. Renotify this application on 5th August, 2020.
