1. Request for a short accommodation is made on behalf of the learned counsel for the Ex-Management and likewise on behalf of learned counsel appearing for in CO.APPL. 1217/2016.
2. Learned counsel appearing for the plaintiff/Hari Impex Pvt. Ltd. in CS(OS) 1691/2014, has pointed out that on the Official Liquidator moving CO.APPL. 3897/2015, this Court vide order dated 01.09.2023 directed that the aforesaid suit shall stand transferred to this Court.
3. Although learned counsel for the plaintiff has alluded to previous order dated 18.02.2014, whereby CO.APPL. 1005/2013 was allowed and it was permitted to pursue the civil proceedings before the competent Court. However, it would be expedient that now in order to have a holistic view of the issues arising in the present winding up proceedings, the suit be tried by this Court.
4. Accordingly, the parties in CS(OS) 1691/2014 shall appear before the Joint Registrar (Judicial) for recording and completion of evidence of the parties.
5. List before the Joint Registrar (Judicial) on 27.05.2024.
6. Re-notify for hearing on all the pending applications before this Court on 06.08.2024.

7. This application is filed on behalf of EPFO, in compliance of the previous directions passed by this Court. Copy of the same is supplied to the learned Senior Standing Counsel for the Official Liquidator. Reply, if any, be filed within four weeks from today.
