1. Applications being I.A. 26869/2025 and I.A. 26870/2025, have been disposed of by the learned Joint Registrar (Judicial) vide order dated 03<sup>rd</sup> December, 2025, wherein, the written statement filed on behalf of defendant no. 5 has been directed to be taken on record, subject to cost of Rs. 10,000/- to the counsel for the plaintiffs.



2. Learned counsel appearing for the plaintiffs submits that the said cost has still not been paid by the defendant no.5.
3. Accordingly, the defendant no. 5 is directed to submit the cost to the counsel for the plaintiffs within a period of one week, from today.
4. Learned counsel appearing for the plaintiffs submits that application of defendant no. 5, i.e., *I.A. 19557/2025* can be heard only after the written statement is formally taken on record, subject to payment of cost of Rs. 10,000/-.
5. He submits that the defendant no. 5 seeks to rely upon certain documents filed along with the written statement, which cannot be relied upon.
6. At this stage, learned counsel appearing for the defendant no. 5 submits that the main counsel is not available on account of some personal exigency and requests for an accommodation.
