% **ORDER**
31.07.2024

1. On the basis of the pleadings, the following issues are framed:-
 - a) Whether the Defendant has breached the terms of the Artist Management Agreement dated 30.01.2020? (OPP)
 - b) Whether the Artist Management Agreements dated 11.05.2018 and 30.01.2020 are null and void and unenforceable in law? (OPD)
 - c) Whether the Plaintiff is entitled to a permanent injunction as prayed? (OPP)
 - d) Whether the Defendant is liable to pay damages of Rs.2,00,00,000/- (Rupees Two Crores only) to the Plaintiff for breach of the terms and conditions of the Artist Management Agreement dated 30.01.2020 in terms of Clause 7.1 thereof? (OPP)
 - e) Whether the Plaintiff is entitled to recover a sum of



Rs.1,61,64,000/- (Rupees One Crore Sixty One Lakh Sixty Four Thousand only) from the Defendant towards the Plaintiff's share of fees for the 48 shows (as per Page 131 of the Plaintiff's list of documents) under the Artist Management Agreements dated 11.05.2018 and 30.01.2020? (OPP)

f) Whether the Plaintiff is entitled to recover a sum of Rs.1,06,67,930/- (Rupees One Crore Six Lakh Sixty Seven Thousand Nine Hundred and Thirty only) from the Defendant towards reimbursement of expenses incurred by the Plaintiff under the Artist Management Agreements dated 11.05.2018 and 30.01.2020? (OPP)

g) Whether the Defendant is liable to render accounts to the Plaintiff as prayed? (OPP)

h) Relief.

2. No other issues arise or pressed by the parties.
3. Let the parties file the list of witnesses within a period of 15 days.
4. Let plaintiff file an affidavit by way of examination-in-chief within a period of four weeks from the date of filing of list of witnesses.
5. List before the learned Joint Registrar for fixing the date of plaintiff's evidence, on 15.10.2024.
6. List before Court on 19.11.2024.
