1. Ld. Counsel for defendants no.1 to 4 has submitted that

6. Replication filed vide diary no.650112/2023 and affidavit of admission/denial of documents filed vide diary no. 650116/2023, on behalf of plaintiff qua defendants no.1 to 4, are still lying under objection. Let appropriate steps be taken as per law for getting the same placed on record.

7. Documents filed on behalf of the plaintiff vide diary no. 650118/2023 are also lying under objection. Let needful in this regard be done.

8. Let the pleadings be completed as per law.
