File is placed before this Court vide order dated 23.01.2025 for issuance of proceedings declaring the appellants as 'Proclaimed Offender.

Head Constable Neeraj, PS Nangloi who executed the process under Section 84 BNSS against appellant, is present in Court and submits that execution report has already been filed. The same is perused and as per which proceedings under Section 84 of BNSS have been duly executed against the appellant. Separate statement of Head Constable Neeraj, PS Nangloi is recorded in this regard. The same is herein below:-

*“Pursuant to the order of Hon’ble Court dated 23.01.2025 by which proceedings under Section 84 BNSS were issued against accused NASIM AHMED @ SAGAR S/o Nazir Ahmad R/o- H-3, H. No. 90, Jalebi Chowk, Sultanpuri, Delhi, I visited the aforesaid residence of the accused and the accused was not found residing there.*



*One Ms. Sabina Khatoon was found present at the said address and she stated that her family purchased said house from Sonu S/o Sh. Ram Dev in year 2021 and she did not know any Nasim Ahmed @ Sagar. Thereafter I got the people of the vicinity assembled and carried out proclamation as per law.*

*Thereafter, copy of the order of the proceedings under Section 84 BNSS was pasted on the main door of house of the accused on 18.03.2025. Copy of the order of the proceedings under Section 84 BNSS was also pasted on the notice boards of Hon'ble High Court on 15.03.2025.*

*The execution report is exhibited as Ex. R/HC/1.*

*I recorded the Statement of Ms. Sabina Khatoon, Owner. The said statement is exhibited as Ex.R/HC/X-1.*

*The DD entry of arrival for the proceedings initiated against accused Nasim Ahmed @ Sagar under Section 84 BNSS on 18.03.2025 is exhibited as Ex. P/HC/Y-1.*

*One photograph taken showing pasting of the process under Section 84 BNSS at the residence of accused Nasim Ahmed @ Sagar is exhibited as Ex. R/HC/Z-1. Process under Section 84 BNSS published in newspapers for Shehzad Alias Sazid, Rajesh Kumar and Nasim Ahmed @ Sagar are already exhibited as Ex. R/HC/Z-2 and Ex. R/HC/Z-3 in CRL.A. 662/2002."*



As per the report, the information has been duly published as per law. It seems that the appellant Nasim Ahmed @ Sagar has absconded and is concealing himself so that warrant cannot be executed against him. The appellant Nasim Ahmed @ Sagar is deliberately and intentionally not appearing before the Court.

Hence, appellant i.e. Nasim Ahmed @ Sagar is hereby declared a proclaimed offender.

Matter is coming up for hearing before the Hon'ble Court on 28.07.2025. Be placed accordingly.
