I am directed to refer to the elections of the Executive Committee (EC) of Volleyball Federation of India (VFI) held on 07.06.2025 under the supervision of the Retd. Justice P.K. Bhat, as per the directions of the Hon'ble High Court of Delhi contained in Order dated 09th May, 2025 passed in W.P (C) No. 1938/2024 titled as "Maharashtra Volleyball Association Vs. Union of India & Ors." and other connected matters and to say that it has been decided to accept the election of the interim Executive Committee of the VFI; and to grant the government recognition with immediate effect, with following Office Bearers:

- The interim body of VFI shall adhere to the mechanism prescribed by the Fédération Internationale de Volleyball (FIVB) and shall follow all instructions of FIVB and actively support its developmental programmes for Volleyball in India.

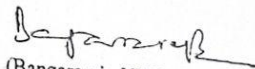

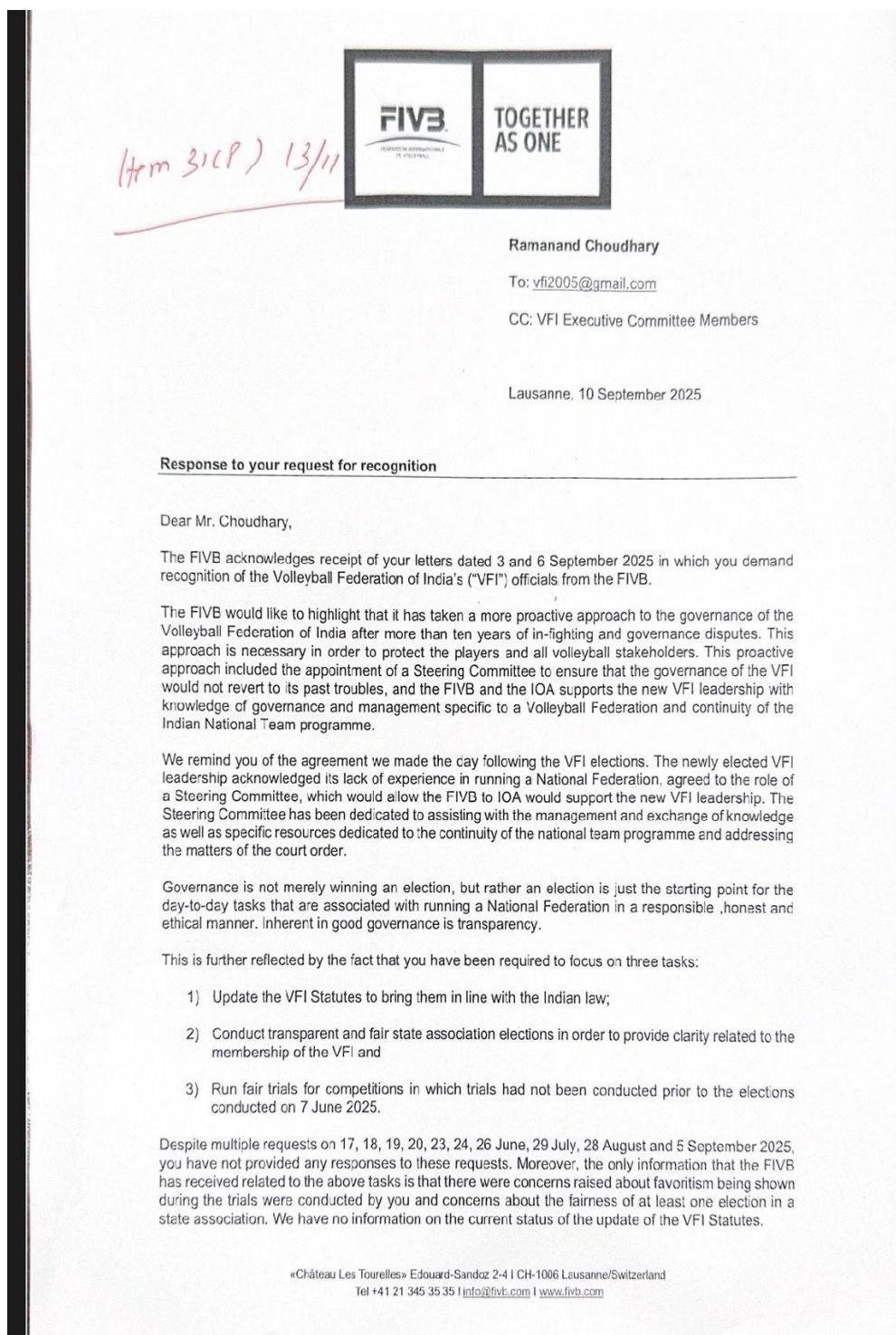

2136/2024 has handed over to this Court a letter dated 10th September, 2025, issued by the *Federation Internationale De Volleyball* (“FIVB”), which reads as under:





The FIVB now firmly believes that, while you have participated in calls with the Steering Committee and promised to provide responses, it is clear by your actions that you have no legitimate interest in working with the Steering Committee, which is non-negotiable for the FIVB. Additionally, you and your organization are making unsubstantiated allegations against the staff of the Steering Committee who were made available to you to assist you in running your operations. All information related to the FIVB's activities in India, including its Empowerment project, were clearly described to you in the introductory meeting that you had with FIVB staff.

Working with the Ad-Hoc Committee, the FIVB has developed great relationships with the Indian Olympic Association and the Indian Ministry of Youth Affairs and Sport. It was fully ready to assist you in growing the sport of volleyball in India and facilitate these relationships. Unfortunately, your letters clearly convey the message that you would prefer not to work with us.

Based on the above, the FIVB has no choice but to withhold any recognition due to your refusal to allow the Steering Committee to properly oversee compliance with the fundamental governance tasks submitted to you. Thus, it will be required to update its Board of Administration about these unfortunate circumstances and consider any and all actions available.

3. Considering the aforesaid letters, it transpires that a divergent stand has been taken by the GOI and the FIVB.
4. Considering the letter dated 10th September, 2025, issued by FIVB, the UOI is directed to consider as to how it shall ensure that the recognition granted by the UOI *vide* letter dated 29th October, 2025 inures to the benefit of VFI in view of the specific provisions of the National Sports Development Code of India, 2011 (“National Sports Code”).
5. Learned counsel appearing for the applicant in application being *CM APPL. 65312/2025* in *W.P.(C) 2136/2024*, submits that the Interim Committee of the VFI, which has been recognized by the GOI for the time being, is undertaking actions, which are beyond its mandate.
6. He submits that the requisite documents in this regard, shall be placed on record. Accordingly, the applicant in the application, i.e., *CM APPL. 65312/2025* in *W.P.(C) 2136/2024*, is allowed to place on record the requisite documents, before the next date of hearing.
7. Let the needful be done.
8. Mr. Sebastian George, petitioner in *W.P.(C) 2174/2024*, who appears through Video Conferencing (“VC”), submits that the VFI has been violating the various provisions of the National Sports Code, which is a serious matter.
9. Learned Senior Counsel appearing for the petitioner in *W.P.(C) 9483/2025*, submits that in the present matter the elections would have be re-held, in consonance with the provisions of the National Sports Code, in view of the various violations of the National Sports Code and orders of this Court.
10. This Court has already clarified in its order dated 10th July, 2025



passed in W.P.(C) 9483/2025, as follows:

“xxx xxx xxx

17. It is clarified that any action taken by the newly elected Executive Committee, shall be subject to the orders of this Court.

xxx xxx xxx”

(Emphasis Supplied)

11. Parties are granted liberty to complete the pleadings, in the meanwhile.
