1. Counsel for the parties have been heard briefly.
2. Mr. Jayant Kumar, counsel appearing on behalf of respondent no.2, submits that in the AGM of respondent no.2 conducted on 5th January, 2026, a new constitution has been adopted by respondent no.2, which is in conformity with the National Sports Code of 2011. He submits that further amendments to the constitution will be made to make it in conformity with the National Sports Governance Act, 2025 ('Act') which has been recently notified on 1st January, 2026 and rules thereunder have been notified on 12th January, 2026.
3. Accordingly, it is directed that the respondent no.2 shall promptly



take steps to make amendments in its constitution to make it in conformity with the Act as well as regulations of the International Federation, FIVB.

4. Respondent no.2 shall file an affidavit placing on record the current draft of the constitution as adopted in the AGM of 5th January, 2026 as well as the proposed amended draft within four (4) weeks from today.
