The pleadings qua the defendant nos. 1, 2 & 5 are complete.

Compliance-affidavit has been filed by the defendant no. 3, vide diary no. 5052558/2025. Same be taken on record.

As per order dated 14.02.2025 of the Hon'ble Court, the defendant no. 4, 16 & 17 are exempted from filing the written statements & they have to only file the compliance-affidavits.

Ld. counsel for the defendant no. 16 submits that he has filed the compliance-affidavit, vide diary no. 4233138/2025 but the same is not showing the official noting, he is directed to contact the registry to do the needful.

The defendant no. 4 & 17 are directed to file the compliance-affidavit in terms of order dated 14.02.2025 before the next date of hearing.

The defendant no. 3 was served via email on 14.04.2025. (*Refer: Order dated 09.05.2025*).

No written statements have been filed by the defendant nos. 6 to 15. The defendant no. 11 was served on 19.03.2025 (*Refer: Order dated 09.05.2025*). The defendant no. 14 was served on 02.04.2025, therefore the prescribed time period to file their written statement(s) by the defendant no. 11 & 14 has expired. Accordingly their rights to file the written statement(s) are closed.

The rest of the defendants i.e. defendant nos. 6 to 10 & 12, 13 & 15 were served on 14.04.2025. (*Refer: Order dated 09.05.2025*). These defendants are yet to file their written statements/compliance-affidavits.
