1. It is submitted that the matter and captioned Crl.M.A. are coming up for hearing before the Hon'ble Court on 08.07.2024.
2. The present matter is listed today for admission/denial of documents in terms of order dated 31.01.2024.
3. As per office noting, original Will dated 27.11.2020 has been received in sealed cover and the same is kept in safe custody at sr. no.4406.
4. Ld. Counsel for plaintiff submits that he seeks some more time for filing affidavit of admission/denial with respect to additional documents, which were taken on record in



terms of order dated 31.01.2024 passed in IA No.12922/2023 and he has further submitted that he has to inspect the original Will for filing of the said affidavit. Not opposed.

5. Perusal of order dated 31.01.2024 passed by the Hon'ble Court would show that it was directed that at the time of admission/denial, the original Will, that would be placed by the defendants, shall be shown to the plaintiff for the purpose of admission/denial. Accordingly, let original Will be shown to the plaintiff for inspection.
6. At this stage, original Will is brought from Registry in closed envelope and Will is taken out from the same and shown to the plaintiff and his counsel and they have inspected the same. The plaintiff shall file affidavit of admission/denial qua additional documents of defendant within two weeks.
7. Let Joint Document Schedule including hard copy of the same be filed at least two weeks before the next date.
8. Both the parties shall file hard copies of their documents at least two weeks before the next date.
9. AR (O) is directed to seal the aforesaid original Will on 17.05.2024 at 02:30 p.m. in presence of both the parties/their counsels. At joint request, in case, the parties or their counsel do not appear on the above said date and time, AR(O) is directed to seal the same in their absence.
10. Re-notify the matter for admission/denial of documents and further proceedings on **30th May, 2024.**
