1. The present matter is listed today for admission/denial of documents in terms of order dated 31.01.2024.
2. As per office noting, Joint Document Schedule was e-filed on 20.06.2024.
3. Hard copies of documents have been filed on behalf of the defendants.
4. Perusal of affidavit of admission/denial of documents filed on behalf of defendants alongwith written statement would show wherein it was mentioned that documents filed by the plaintiff in Index-IV from sr. no.2 to 9 needs no comment. Ld. Counsel for defendants has submitted that he has mentioned 'no comments' in response to the said documents as he is not disputing the same.

8. In terms of affidavit of admission/denial of documents filed on behalf of the plaintiff, the plaintiff has admitted three documents of the defendants, which are exhibited as Ex.D-1 to Ex.D-3.
9. Admission/denial of documents stands concluded.
10. Hard copy of Joint Document Schedule has not been filed. Time sought on behalf of defendant for filing the same. Let the same be filed before next date of hearing.
