1. The case is at the stage of admission/denial of documents. The plaintiff has filed 34 documents in the present suit.
2. The right of defendant no.1 to file written statement was closed on 22.11.2023, and as no affidavit of admission/denial of plaintiff's documents has been filed by defendant no.1, all the documents of the plaintiff are



deemed to have been admitted by defendant no.1.

3. The document i.e. letter dated 11.02.2022 has been admitted by all the defendants and same is marked as Ex. P1. The existence of two documents of plaintiff have been admitted by all the defendants, however, the contents have been denied and the same are marked as Ex. P2 and Ex. P7.

4. Defendant no.3 has not filed any affidavit of admission/denial with respect to plaintiff's documents filed along with IA No. 3129/2022, IA No. 3594/2022 and IA No. 16512/2022 and the plaintiff's documents filed vide diary no. 729414/2022, hence all these documents are deemed to be admitted by defendant no.3.

5. Defendant no.1 has not filed any document in the present suit. Defendant no.2 has filed four documents, in respect of which the right of plaintiff to file the affidavit of admission/denial was closed on 17.11.2022, hence, all the documents of defendant no.2 are deemed to be admitted by the plaintiff. The same are marked as Ex. D2/1 to Ex. D2/4.

6. Defendant no.3 has filed six documents, in respect of which the right of plaintiff to file the affidavit of admission/denial was closed on 17.11.2022, hence, all the documents of defendant no.3 are deemed to be admitted by the plaintiff. The same are marked as Ex. D3/1 to Ex. D3/6.

7. Admission/denial of documents stands concluded. Necessary entries in column no.7 of Joint Document Schedule have been made.

8. The matter is now required to be placed before the



Hon'ble Court in terms of Rule 16 Chapter VII of Delhi High Court (Original Side) Rules, 2018.

9. The file may be placed before the Hon'ble Court on 17.07.2025, for further directions. In the meantime, the parties may explore the possibilities of settlement.
