1. Ld. Counsel for respondent no.1 already submitted that he did not wish to file any reply to captioned IAs.
2. The opportunity of respondents no.2(i) to (v), LRs No.A to C of deceased respondent no.7, respondent no.5 to file reply to captioned IAs has already been closed.
3. Ld. Counsel for defendant no.4 has submitted that he has not received copy of the captioned IA till date. On the other hand, Ld. Counsel for plaintiff has submitted that he had sent copy of the captioned IA to Ld. Counsel for defendant no.4 through email on 18.04.2024. However, Ld. Counsel for defendant no.4 submits that he has not received any such email.
4. Heard. Without prejudice to the rights & contents of plaintiff and defendant no.4, the plaintiff is directed to supply copy of the captioned IA to defendant no.4 within one week.
5. After receiving copy of the captioned IA, the defendant no.4 may file his reply to the captioned IA within four weeks and rejoinder thereto be filed within two weeks thereafter.
6. No reply to the captioned IA has been filed on behalf of defendant no.6. Last opportunity is given to the defendant no.6 for filing reply to the captioned IA within four weeks as last opportunity and rejoinder thereto be filed within two weeks thereafter.

7. It is submitted that an application for impleadment of LRs of respondent no.7 is pending for consideration.
8. Perusal of record would show that matter has not been listed before the Hon'ble Court after 01.10.2019.
