In the present bunch of petitions, the Petitioners are seeking initiation of the contempt proceedings against the Respondents for the wilful defiance of the directions contained in the orders dated 26.07.2024 in W.P.(C) No. 10238/2024, 30.08.2024 in W.P.(C) No. 12043/2024, 10.09.2024 in W.P.(C) No. 12694/2024 and 10.09.2024 in W.P.(C) No. 12678/2024 respectively passed by this Court.

5. Learned counsels for the Respondents are present on advance notice.

6. The short issue in the present matters is re-fixation of the monthly pension/pensionary benefits on enhancement of pay scales in terms of the recommendation of 5th Pay Commission w.e.f. 01.01.1996 to 10.10.1997.

7. Learned counsels for the Respondents submit that the matter has been taken up by the CISF with the Ministry of Home Affairs, and certain clarification has been sought from the Department of Personnel and Training [“DOPT”] and once the decision is taken, the matter would be taken up with the Ministry of Finance for financial approval besides the Ministry of Law.
