ORDER

1. This hearing has been done through hybrid mode.
2. *Vide* order dated 27.08.2025, this Court had passed the following directions: -

“3. Learned counsel appearing on behalf of the respondent has handed up in Court today an order dated 18.08.2025 passed by the Hon’ble Supreme Court in SLP Diary No. 35449/2025, whereby the SLP preferred by the respondent has been dismissed. However, eight weeks’ time from the said date has been granted to release/disburse the amount and comply with the order passed by this Court.

4. In view of the above, let a compliance report be filed before the next date of hearing.

5. In case of any non-compliance, the said officer shall remain present in the Court on the next date of hearing.”

3. DIG, Dhinakaran, Personnel, DTE, CRPF, is present in the Court today.
4. Learned counsel appearing on behalf of the respondents submits that the compliance is at its final stage. It is submitted that the compliance of the judgment also involves similarly situated persons, who would also get benefit from the judgment, as in case of the petitioners.
5. Be that as it may, the Hon’ble Supreme Court of India while dismissing the SLP Diary No. 35449/2025 had given 8 weeks’ time from the said date *i.e.*, 18.08.2025, to comply with the order dated 14.08.2024.
6. No compliance affidavit/any affidavit has been placed on record by the respondents.



7. In these circumstances, let respondent no. 3, *i.e.*, Inspector General, Personnel, CRPF, remain present before this Court on the next date of hearing, along with the relevant records.
