1. Learned counsels for parties submit that notice has not been issued.

**IA No. 4676/2024 u/s 151 CPC to place on record
evidence by way of affidavit of defendant no.2 (c)**

2. None appears for defendant no.2 (c) today. Record perused. Perusal of record reveals that the order dated 28.02.2024, whereby the right of defendant no. 2 (c) to file evidence by way of affidavit was closed has been set aside by the Hon'ble Court vide order dated 25.10.2024.

3. Learned counsels for plaintiff and defendant no.8 (c) submit that the cross-examination of defendant no.2 (c) is being recorded by learned Local Commissioner and the captioned IA has become infructuous. In view of the



submissions made, the captioned IA is disposed off as infructuous.
