CCP(O) 5/2024 (by plaintiff)

1. Time sought on behalf of both respondents/defendants no.1 & 2 to file reply to the captioned IA.
2. Let reply to captioned CCP(O) within three weeks and rejoinder thereto be filed within three weeks thereafter.

I.A. No. 8855/2022 (by defendants no.1 and 2 u/O VII Rule 11 of CPC)

3. Reply to the captioned IA was filed on behalf of plaintiff.
4. Ld. Counsel for defendants no.1 & 2 submits that he does not wish to file rejoinder to the said reply.
5. Pleadings qua the captioned IA are complete.

I.A. No. 3729/2022 (by plaintiff u/O XXXIX Rules 1 & 2 of CPC)



6. It was already submitted on behalf of defendant no.3 and 4 that they did not wish to file reply to the captioned IA.
7. Reply to the captioned IA was already filed on behalf of defendants no.1 and 2.
8. Ld. Counsel for plaintiff submits that he has filed rejoinder to the said reply. However, the same has not come on record. Let needful in this regard be done.

I.A. No. 7141/2022 (u/O I Rule 10 of CPC by defendant no.4)

9. Today the captioned IA is listed for arguments.
10. At request of Ld. Counsel for defendant no.4, re-notify the captioned IA for arguments on next date of hearing.

I.A. No. 7636/2022 (by plaintiff u/S 151 of CPC seeking directions against defendant no.3)

11. Reply to the captioned IA already filed on behalf of the defendant no.3. No rejoinder to the said reply was filed on behalf of the plaintiff despite last opportunity. Time sought. Not opposed. In the interest of justice, one more opportunity is granted to the plaintiff for filing rejoinder within four weeks.

12. It is submitted that the present matter and all pending applications are coming up for hearing before Hon'ble Court on 09.07.2024.
13. As per office noting, nothing fresh has been filed.
14. Documents filed by defendants no.1 & 2 in compliance of order dated 13.09.2022 vide diary no.1845814/2023 dated 28.09.2023 have now come on record.
15. Perusal of record would show that written statement, affidavit of admission/denial of documents as well as



documents with list of documents on behalf of defendants no.1 and 2 are already on record.

16.No replication and affidavit of admission/denial filed on behalf of plaintiff qua defendants no.1 and 2.

17.Perusal of record would also show that separate written statements alongwith affidavits of admission/denial of documents were already filed on behalf of the defendant no.3 and defendant no.4.

18.Separate replications were already filed by plaintiff qua defendant no.3 and defendant no.4.

19.Affidavit of admission/denial of documents was already filed on behalf of plaintiff qua defendant no.3.

20.It is submitted that no document has been filed on behalf of defendant no.4 alongwith written statement, therefore, affidavit of admission/denial of documents is not required to be filed by the plaintiff qua defendant no.4.

21.Let the pleadings be completed as per law.

22.Re-notify the present matter for completion of pleadings and further proceedings on **03rd May, 2024**.
