Proceedings are being conducted through hybrid mode.

I.A. No. 9951/2024 (by plaintiff u/S 151 CPC for closing right of contemnors/defendants no.1 & 2 to file reply to CCP(O) 5/2024)

1. Ld. Counsel for contemnors/defendants no.1 & 2 accepts notice of the captioned IA and submits that he has not received copy of the same.
2. Ld. Counsel for plaintiff submits that he has already supplied copy of the captioned IA to Ld. Counsel for contemnors/defendants no.1 & 2 through email on 24.4.2024. However, Ld. Counsel for contemnors/defendants no.1 & 2 submits that he will have to check the same. He has also sought one more copy.



3. Heard. Without prejudice to rights & contentions of both the parties, let copy of the captioned IA be supplied to Ld. Counsel for contemnors/defendants no.1 & 2 during the course of the day. Let reply to the captioned IA be filed within three weeks and rejoinder thereto be filed within two weeks thereafter.

4. No reply to the captioned CCP(O) has been filed on behalf of both contemnors/defendants no.1 & 2.
5. IA No. 9951/2024 seeking closure of right of contemnors/defendants no.1 & 2 to file reply to the captioned CCP(O) is pending for consideration on behalf of plaintiff.

I.A. No. 8855/2022 (by defendants no.1 and 2 u/O VII Rule 11 of CPC)

6. Pleadings qua the captioned IA are already complete.

I.A. No. 3729/2022 (by plaintiff u/O XXXIX Rules 1 & 2 of CPC)

7. It was already submitted on behalf of defendant no.3 and 4 that they did not wish to file reply to the captioned IA.
8. Reply to the captioned IA was already filed on behalf of defendants no.1 and 2. Rejoinder to the said reply stated to be filed on behalf of plaintiff has not come on record till date. Let appropriate steps be taken as per law.

I.A. No. 7141/2022 (u/O I Rule 10 of CPC by defendant no.4)

9. Today the captioned IA is listed for arguments.
10. At joint request, re-notify the captioned IA for arguments on next date of hearing.

11.Reply to the captioned IA already filed on behalf of the defendant no.3. No rejoinder to the said reply was filed on behalf of the plaintiff despite many opportunities. Right of the plaintiff to file the same stands closed.

12.It is submitted that matter and captioned IA are coming up for hearing before Hon'ble Court on 09.07.2024.

13.As per office noting, nothing fresh has been filed.

14.Pleadings in the present matter qua defendants no.3 and 4 are already complete.

15.Perusal of record would show that written statement, affidavit of admission/denial of documents as well as documents with list of documents on behalf of defendants no.1 and 2 are already on record.

16.No replication and affidavit of admission/denial filed on behalf of plaintiff qua defendants no.1 and 2.

17.Ld. Counsel for defendants no.1 & 2 has submitted that statutory period for filing replication by plaintiff qua defendants no.1 & 2 has already expired. Ld. Counsel for plaintiff submits that he will file replication to written statement of defendants no.1 & 2 alongwith application for condonation of delay. Let appropriate steps be taken as per law.

18.Re-notify the present matter for further proceedings on **28th May, 2024.**
