1. Learned counsel for the Petitioner/plaintiff states that defendant nos. 1 and 2 are in wilful non-compliance of the unambiguous and specific directions issued by the predecessor Bench at paragraph 8 of the order dated 13.09.2022. He states that the non-compliance has been duly tabulated at document no. 5 of this contempt petition.
2. Learned counsel for defendant no. 1 states that he has filed a short affidavit dated 27.05.2023 and has placed along with the affidavit the



missing documents in respect of which production has been sought by the Petitioners/plaintiffs. He admits that there continues to remain deficiency in some of the documents to be filed inasmuch as the document by which the nomination was changed in favour of defendant no. 3 has not been placed on record till date. He states that defendant no. 1 will ensure that the said documents is also filed within two (2) weeks and original is produced for inspection of the Petitioners/plaintiffs before the next date.

3. List before the learned Joint Registrar (Judicial) on 20.08.2024 to enable defendant no. 1 to offer inspection of the originals of the documents annexed with short affidavit dated 27.05.2024 as well as the originals of the additional documents, which defendant no. 1 has undertaken to file within two weeks.

4. It is made clear that if the defendant no. 1 fails to file the documents as directed by the Court on 13.09.2022, the Branch Manager shall remain personally present in Court and defendant no. 1 will also place on record the names of each of the Branch Managers who were appointed to this branch at the relevant time from the first nomination until the change in favour of defendant no. 3.
