I.A. No. 8855/2022 (u/O VII Rule 11 of CPC)

1. Ld. Counsel for plaintiff seeks time for filing reply to the captioned IA.
2. The plaintiff may file reply to the captioned IA within four weeks with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.
3. Re-notify the captioned IA for completion of pleadings and further proceedings on **09th December, 2022.**



I.A. No. 3729/2022 (u/O XXXIX Rules 1 & 2 of CPC)

1. As per office noting for 27.07.2022, reply to the captioned IA was filed on behalf of defendants no.1 and 2 on 19.07.2022.
2. The plaintiff may file rejoinder to reply of defendants no.1 and 2 within two weeks with advance copy to the opposite party.
3. Ld. Counsel for defendants no.3 and 4 has submitted that they have to check whether any reply to the captioned IA has been filed or not and in case, the same has not been filed, he will file the same within two weeks from today.
4. The defendants no.3 and 4 may file reply, if any, to the captioned IA within two weeks from today with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.
5. Re-notify the captioned IA for completion of pleadings and further proceedings on **09th December, 2022.**

I.A. No. 7141/2022 (u/O I Rule 10 CPC by defendant no.4)

1. Ld. Counsel for plaintiff seeks time for filing reply to captioned IA
2. The plaintiff may file reply to the captioned IA within four weeks with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.
3. Re-notify the captioned IA for completion of pleadings and further proceedings on **09th December, 2022.**

I.A. No. 7636/2022 (u/S 151 CPC)

1. As per office noting, reply to the captioned IA was filed on behalf of defendant no.3 vide diary no.1555649 dated 14.09.2022.
2. The plaintiff may file rejoinder to the reply filed by defendant no.3 within two weeks from today.



3. Re-notify the captioned IA for completion of pleadings and further proceedings on **09th December, 2022.**

CS(OS) 134/2022

1. Ld. Counsel for plaintiff has submitted that vide order dated 13.09.2022 while disposing off IA No.3732/2022, certain directions were given to defendant no.1 Bank, however, the same have not been complied.
2. Ld. Counsel for defendant no.1 has submitted that the directions in terms of order dated 13.09.2022 will be complied within a week.
3. Written statement on behalf of defendants no.1 and 2 is stated to have been filed. However, the same neither find mention in the office noting nor available on record. Let appropriate steps be taken as per law.
4. As per office noting for 13.09.2022, written statement alongwith affidavit of admission/denial was filed on behalf of defendant no.4 vide diary no.767958 dated 28.04.2022.
5. Office noting for 27.07.2022 would show that replication to the written statement of defendant no.4 was filed on behalf of plaintiff vide diary no.1126180 dated 11.07.2022.
6. Ld. Counsel for plaintiff has submitted that since no document was filed on behalf of defendant no.4, no affidavit of admission/denial of documents has been filed qua defendant no.4.
7. Office noting for 27.07.2022 would further show that replication to the written statement of defendant no.3 was filed vide diary no. 1126172 dated 11.07.2022. Perusal of record would further show that affidavit of admission/denial of documents was also filed on



- behalf of defendant no.3 vide diary no.768018/2022.
8. However, perusal of the record would show that written statement filed on behalf of the defendant no.3 is not available on record. Registry to report about the same on next date of hearing.
 9. Office noting for 27.07.2022 would show that affidavit of admission/denial of documents was filed on behalf of petitioner vide diary no.1126147 dated 11.07.2022, however, the same is not available on record. Registry to report about the same on next date of hearing.
 10. Let the pleadings be completed by the parties as per law.
 11. Let Joint Document Schedule, including hard copy of the same and hard copy of the documents, be filed within six weeks from today.
 12. Ld. Counsel for defendants no.1 and 2 seeks time to produce the documents in terms of order dated 13.09.2022.
 13. At request of both the parties, the defendant no.1 may produce the documents in terms of order dated 13.09.2022 passed by Hon'ble Court, before undersigned on 04th November, 2022.
 14. Re-notify the present matter for production of documents on **04th November 2022** and for completion of pleadings and further proceedings on **09th December, 2022**.
