1. This hearing has been conducted through hybrid mode.

**CM APPL. 16429/2026 (for exemption)**

2. Allowed, subject to all just exceptions. Application is disposed of.

**CM(M) 544/2026 & CM APPL. 16428/2026 (for stay)**

3. This is a petition filed by the petitioners under Article 227 of the Constitution of India, 1950 assailing the orders dated 16<sup>th</sup> February, 2026 and 10<sup>th</sup> March, 2026 passed by the learned Trial Court in case bearing M-EX 24/2025.

4. Learned counsel for the petitioners submits that an advance notice of the present petition has been served upon the respondent and to his counsel through e-mail. However, no one has appeared on behalf of the respondent.

5. Learned counsel for the petitioners further submits that the present petition is of urgent nature as the NBWs have been issued against the



petitioners. The petitioner No.1 is a lady aged about 73 years and has also health issues. The Trial Court has issued the Non-Bailable Warrants (NBWs) against the petitioners without following the due process of law, as provided under Section 51 read with Order XXI Rule 37 of the Code of Civil Procedure, 1908.

6. The operative portion of the impugned order dated 10<sup>th</sup> March, 2026 reads as follows:

*“In view of the facts and circumstances of the case, the continued non-compliance of the order dated 16.02.2026, and the evasive conduct of the directors of the Judgment Debtor company, this Court is constrained to take coercive measures. Accordingly, it is ordered as follows:*

*1. Non-Bailable Warrants (NBWs) be issued against the directors of the Judgment Debtor Company, namely:*

*• Sh. Rishabh Singhvi*

*• Ms. Amla Singhvi, both*

*R/o E-227, East of Kailash, Opposite National Heart Institute, New Delhi – 110065.*

*2. Warrant of attachment against the immovable property of directors i.e E-227, East of Kailash, Opposite National Heart Institute, New Delhi – 110065 also be issued subject to steps*

*3. The warrants of arrest shall be executed through the concerned SHO in accordance with law. S.H.O concerned is also directed to provide the necessary assistance in the attachment of the above property, if necessary.*

*4. The Decree Holder shall take necessary steps for execution of the warrants within the prescribed time*

*DH is directed to appear before Ld. ACJ(SE) on 17.03.2026..”*

7. Upon the petitioners taking necessary steps, let notice be issued to the respondent through all permissible modes including *dasti*, returnable on the next date of hearing.



8. List on 23<sup>rd</sup> March, 2026.
9. In the meantime, the NBWs issued against the petitioners by the Trial Court shall remain stayed.
10. A copy of this order be given *dasti* under the signatures of the Court Master.
