IA No. 4848/2021 (application filed by defendant no.2 u/O I Rule 10 CPC)



This application has been filed by defendant no.2 Sh. Rajiv Nanda for deletion of his name from the array of parties on the ground that he has no right in the suit property and he has been made party to the suit only because he is the husband of defendant no.1 Mrs. Deeba Ikram@Deeba Khan.

Learned counsel for the plaintiff has stated that he has no objection to the application.

Learned counsels for other defendants have also stated that they have no objection to the application.

Heard. Keeping in view the submissions of the parties and grounds mentioned in the application, application stands allowed. The name of defendant no.2 Sh. Rajeev Nanda is deleted from the array of parties.
