1. It is stated by learned counsel for the applicant/defendant no.1 that the captioned IA has not been filed for placing the additional documents on record but to take on record the documents intended to be filed by defendant no.1 with the Written Statement but could not be filed due to counsel's inadvertent error. He submits that copy of the said documents though, has already been supplied to all the parties.

2. At this stage, it is found that there are technical errors in the captioned IA. Learned counsel for the applicant seeks permission to withdraw the captioned IA with a liberty to file fresh application. Allowed. Accordingly, the captioned IA stands disposed as being withdrawn.

3. Heard. In view of reasons stated in the application, the captioned IA stands allowed as prayed for and amended Written Statement filed by the defendant no.1 is allowed to be taken on record. Accordingly, the captioned IA stands disposed of.

5. Amended Written Statement filed by the defendant no.1 is taken on record vide order of even date. The plaintiff is directed to file Replication to the same within stipulated period as prescribed by law with copy to the opposite side.

6. It is stated by learned counsel for the defendant no.3 that he has also filed amended Written Statement vide diary no.3870327/24 but the same is lying under objections, as per office note. Learned counsel for the defendant no.3 is directed to take requisite steps to bring the same on record.

7. The plaintiff is at liberty to file Replication to the same within stipulated period as prescribed by law with copy to the opposite side.

8. It is stated by learned counsel for the defendant no.4 that he has also filed amended Written Statement but fails to disclose the diary number and date of filing. The same is not on record. Learned counsel for the defendant no.4 is directed to take requisite steps to bring the same on record.

9. It is stated by learned counsel for the plaintiff that he has not received copy of the same. So, learned counsel for the defendant no.4 is directed to supply copy of amended Written Statement to learned counsel for the plaintiff



within one week through ~~email~~.

10. In view of above and since the date before the Hon'ble Court is short, the matter may be placed before the Hon'ble Court on date already fixed i.e. 18.10.2024, for further directions.
