1. Vide order dated 19.09.2024, Amended Written Statement filed by the Defendant no.1 was taken on record and as per the record, Replication to the Written Statement of Defendant no.1 to the Amended Complaint is already on record. Revised Affidavit of Admission/Denial of documents filed by defendant no. 1 is already on record. **Hence, pleadings qua defendant no. 1 are complete.**



2. As per record, the Revised Affidavit of Admission/Denial qua documents filed by the plaintiffs to the documents of Defendant no.1 is also on record.

3. As per office note, fresh vakalatnamas have been filed on behalf of defendant no. 1&3.

4. Record reveals that vide order dated 19.01.2023, the Defendant no.2 has been deleted.

5. Further, as per record, amended Written Statement filed by Defendant no.3 is already on record.

6. The right of the plaintiff to file Replication alongwith Affidavit of Admission/Denial of the documents to the Written Statement filed by Defendant no.3 has already been ordered to be closed vide order dated 14.01.2025. **Hence, pleadings qua defendant no. 3 are also complete.**

7. Further, as per record, amended Written Statement filed by defendant no. 4 is already on record. The defendant no. 4 has also filed some documents in the present matter. The Revised Affidavit of Admission/Denial of the documents filed by Defendant no.4 is already on record.

8. Further, vide order dated 24.03.2025, the right of the plaintiff to file Replication and Affidavit of Admission/Denial of the documents qua defendant no.4 was ordered to be closed. **Thus, pleadings qua defendant no. 4 are also complete.**

9. As per office note, the Joint Schedule of documents has not been filed on behalf of the plaintiff. Learned counsel for the plaintiff submits that the draft Joint Schedule of documents has been signed by the learned counsel for defendant no. 4, however, inputs from the learned respective counsels for



defendant no. 1&3 are still awaited. The draft copy of Joint Schedule of documents has been shared physically with the learned counsels for defendant no. 1&3 and inputs to the same, if any, be provided within three weeks.

10. Thereafter, let the Joint Schedule of documents be filed by the plaintiff in digital as well as physical form, before the next date of hearing.

11. The physical copies of the documents of the plaintiff are already on record. The defendants are directed to file physical copy of the documents of which e-copy already filed on record, if not filed earlier, before the next date of hearing.

12. Re-notify the matter for Admission/Denial of documents on 18.03.2026.

IA No.30933/2025 under Section 151 of CPC moved by defendant no. 1 seeking directions.

13. Issue notice.

14. In view of the proceedings conducted today, no further directions required.

15. Above captioned IA stands disposed of accordingly.
