1. The Court has perused the affidavit filed by the respondent-University dated 30.11.2023, which appears to have been filed in compliance of the order passed by this Court on 19.10.2023.

2. The paragraph no.2 of the said affidavit read as under:-

*“2. It is humbly submitted that the present compliance affidavit is being filed in compliance of the order dated 19.10.2023 wherein the Respondent University filed an additional affidavit stating that the Respondent University had resolved and decided to reconsider the date of registration of the petitioner in the Ph .D. course in same terms as the date of the registration as Mr. Hilal. It is further submitted that the Respondent University conducted the Departmental Research Committee (hereinafter referred to as "DRC ") of the Department of Art History & Art Appreciation, JMI in its Meeting held on 15.11.2023, the DRC rectified the date of admission of registration of the petitioner w.e.f. 17 .09 .2018 in terms of the date*



*mentioned on the first fee slip of the petitioner. It is pertinent to mention that the Board of Studies(hereinafter referred to as "BOS " ) held the Meeting of the Department of Art History & Art Appreciation, JMI dated 16.09.2023 further approved the agenda of the rectification of the date of admission of the registration of the petitioner w. e.f. 17 .09 .2018 in terms of the date mentioned on the first fee slip of the petitioner and the same will be put up before the Faculty Committee.”*

3. It is, thus, seen that the Departmental Research Committee of Department of Art History & Art Appreciation, JMI in its Meeting held on 15.11.2023, rectified the date of admission of registration of the petitioner w.e.f. 17.09.2018, instead 11.06.2021.
4. Further, it is observed that the rectification of the date of admission of the registration must ensure further upgradation to the position of senior research fellow and other consequential benefits as required under the extant regulations.
5. The respondent-University is directed to place on record an affidavit indicating therein, any further consequences to be followed in the petitioner's benefit upon rectification of the date of registration and as to whether, the benefit of those consequences have been extended to the petitioner or not.
6. Let the same be done within a period of 10 days from today.
