1. With the consent of the parties and based on the pleadings, the following issues are settled:-

- (i) Whether the Plaintiff is entitled to an order of permanent injunction restraining the Defendants from using the impugned marks of the Plaintiff? OPP
- (ii) Whether the use of the impugned trademark MY BACHPAN PLAY SCHOOL amounts to infringement of trademarks of the Plaintiff? OPP
- (iii) Whether the use of the impugned trademark MY BACHPAN PLAY SCHOOL amounts to passing off of trademarks of the Plaintiff? OPP
- (iv) Whether the use of the impugned trademark MY BACHPAN



PLAY SCHOOL amounts to infringement of copyright of the Plaintiff? OPP

(v) Whether the use of the impugned trademark MY BACHPAN PLAY SCHOOL amounts to passing off of copyright of the Plaintiff? OPP

(vi) Whether the Plaintiff is entitled to rendition of accounts and/or damages and for what amount? OPP

(vii) Whether Plaintiff is entitled to punitive damages? OPP

(viii) Whether Plaintiff is entitled to order for delivery up for purposes of destruction of all impugned goods, bags, labels, dies, stationary, books, uniforms, printed matter and advertisement material, board, etc. and any other infringing copies or media used by the Defendants in pursuit of his infringing activities? OPP

(ix) Cost

(x) Relief.
