1. Learned counsel for the respondents submits that a connected matter being W.P.(C) 3653/2024, is listed on 30th September, 2026.

3. Learned counsel for the petitioners draws the attention of this Court to the Evidence Affidavit of MW-1, i.e., Mr. Vinod Kumar, Administrative Officer, Hospital Administrative Department, Municipal Corporation of Delhi ("MCD"), wherein, it has been stated as follows:

2. I say that , in the room various medicines worth Rs. 3,53,022/- wear found stacked . The official , In charge Pharmacy was unable to provide the complete chain of record, so that medicine received from the main store and distributed, could not be reconciled, on the pretext that the record got burnt in a fire incident on 24/07/2018 which happened in a abandoned toilet room. Therefore, the matter was referred to the vigilance department for further investigation. Investigation report copy is EX-MW1/1

4. He submits that the aforesaid Affidavit refers to the investigation report, i.e., *Ex-MW1/1*. However, the same is not part of the Trial Court Record.
