Ld. counsel for the defendant no. 1 submits that he has already filed the written statement, vide dairy no. 4295258/2025 but the same is under objections. Objections be removed as per law, thereafter replication be filed in accordance with law.

It has been submitted by both the parties that the matter is also pending in mediation between plaintiff and defendant no. 1 on 27.11.2025 at 03:00 pm.

Ld. counsel for the defendant no. 2 submits that he also wants to join mediation proceedings. Not opposed by the plaintiff. The defendant no. 2 is also at liberty to join the mediation proceedings on 27.11.2025 at 03:00 pm before Delhi High Court Mediation & Conciliation Centre.

IA No. 19018/2025 (u/o 1 Rule 151/w Section 151 CPC)

Ld. counsel for the plaintiff submitted that she does not want to file any rejoinder to the reply of proposed defendant Mr. Shravan Kumar. Submissions be taken on record, the right of other proposed defendant Mr. Aman Kalsi has already been closed, vide order dated 23.09.25. Therefore, the pleadings are complete in the said IA.

Arguments heard. During the visit of the Local Commissioner on 08.03.2025, the infringed goods were found from the premises of proposed defendant Mr. Aman Kalsi proprietor of “*Aman Auto Spares*” situated at “*2185, Gali No.-62, Naiwala, Karol Bagh, Delhi-110005*” as well as from the premises of Mr. Shravan Kumar owner of “*3rd Floor, Building No. 2185, Gali no.-62, Naiwala, Karol Bagh, Delhi-110005*”. Accordingly, both Mr. Aman Kalsi as well as Mr. Shravan Kumar are proper and necessary party to the suit. Hence, the application is allowed and they are impleaded as defendants.
