7. Reply has been filed on behalf of defendant no. 1.

8. Learned counsel for plaintiff submitted that he will file the rejoinder, if any, before next date of hearing or he will make the appropriate submissions before the Hon'ble Court qua both the aforesaid IAs.

9. Reply filed by plaintiff. Learned counsel for defendants submitted that he will file the rejoinder, if any, before next date of hearing or he will make the appropriate submissions before the Hon'ble Court qua the aforesaid IA.
