CS(COMM) 100/2021 and CS(COMM) 285/2021

1. The learned Counsel for the Parties jointly submit that in view of the



nature of disputes involved and the pendency of the present cross Suits being CS(COMM) 100/2021 and CS(COMM) 285/2021 along with their connected Applications, it would be appropriate and in the interest of justice that the said cross Suits are consolidated and heard together.

2. In view of the consent of the Parties for consolidation of the proceedings and in order to avoid multiplicity of proceedings and conflicting decisions, in exercise of powers of consolidation under Rule 26 of the Delhi High Court Intellectual Property Rights Division Rules, 2022, it is directed that:

- i) CS(COMM) 100/2021 and CS(COMM) 285/2021 shall stand consolidated.
- ii) CS(COMM) 100/2021 shall be treated as the lead matter.
- iii) All pending applications in both the Suits, including I.A. 3133/2021, I.A. 4316/2021, I.A. 8041/2021 & I.A. 11372/2022 in CS(COMM) 100/2021 and I.A. 7419/2021 in CS(COMM) 285/2021, shall be heard together.
- iv) Parties shall file combined Affidavit of Evidence of their respective witnesses within a period of six weeks.

3. The Registry is directed to tag the records of CS(COMM) 285/2021 along with CS(COMM) 100/2021.
