I.A. 2719/2024 (under Order XXXIX Rules 1 and 2 of the CPC)

1. Vide order dated 5th February, 2024, an interim injunction was granted



against the defendant no.1 and certain directions were issued to the defendant no.2, 3, 4, 7, 8 and 9.

2. In view of the compliance carried out in terms of the order dated 5th February, 2024, the defendants no.2, 7 and 8, were deleted from the array of parties and a decree was passed against the defendants no.3, 4 and 9 in terms of the prayer clause contained in paragraph nos. 65(d), (e) and (i) of the amended plaint on 27th September, 2024.

3. The defendant no.9 was subsequently deleted from the array of parties *vide* order dated 28th November, 2024.

4. Since the reliefs claimed against the aforesaid defendants stand satisfied, counsel for the plaintiffs does not press for further reliefs prayed for in the present application at this stage.

5. Accordingly, the present application is disposed of as not pressed.

6. Amended memo of parties be filed within one (1) week.

7. Summons to the defendant no.12 are yet to be issued in the suit.

8. Issue summons to the defendant no.12 through all permissible modes.

9. The summons shall state that the written statement shall be filed by the aforesaid defendant within thirty (30) days from the date of the receipt of summons. Along with the written statement, the aforesaid defendant shall also file affidavit of admission/ denial of the documents of the plaintiff, without which the written statement shall not be taken on record.

10. Replication thereto, if any, be filed on behalf of the plaintiff within thirty (30) days from the receipt of the written statement. Along with the replication filed by the plaintiff, affidavit of admission/ denial of the documents of the aforesaid defendant be filed by the plaintiff.
