CRL.M.A. 8991/2026 (*Exemption*)

1. Allowed, subject to all just exceptions.
2. The present application is disposed of.

CRL.M.A. 8992/2026 (*Delay 27 days in re-filing*)

3. By virtue of the present application under *Section 528* of the Bharatiya Nagarik Suraksha Sanhita, 2023 (**BNSS**), the petitioner seeks condonation of delay of *27 days* in re-filing the present petition.
4. Considering the assertions made, the present application is allowed and the delay of *27 days* in re-filing the present petition is condoned.
5. The present application is disposed of.

6. By virtue of the present appeal under *Section 14A* of the Scheduled



Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 (**SC/ST Act**) read with *Section 528* BNSS, the appellant seeks to challenge the judgment on conviction dated 21.11.2025 and order on sentence 08.12.2025 passed by learned ASJ, South District, Saket Courts, New Delhi (**learned Trial Court**) in SC No.515/2022 arising out of FIR No.330/2022 dated 16.08.2022 registered at PS: Tigri under *Sections 3(1)(r)/3(1)(s)* SC/ST Act.

7. Issue notice.
8. Learned APP appearing for the State accepts notice.
9. For the reasons stated therein, Admit.
10. Let TCR be requisitioned in the digitised form from the learned Trial Court within a period of *four weeks*.
11. List this appeal in due course in the category of '*Regulars*' as per the year of its seniority.

CRL.M.(BAIL) 609/2026 (*Suspension of sentence*)

12. By virtue of the present application under *Section 430* BNSS, the appellant seeks suspension of the sentence imposed on him *vide* the aforesaid order dated 08.12.2025 passed by the learned Trial Court till the disposal of the present appeal.
13. Issue notice.
14. Learned APP for the State accepts notice. She submits that she shall be filing the Status Report along with SCRB Report, if needed, at least *one week* prior to the next date of hearing.
15. Upon the appellant taking requisite steps within a period of *one week*, issue notice to the respondent nos.2 and 3 by all permissible modes, returnable on 05.05.2026.



16. Keeping in view the nature of the facts and disputes involved, the parties are hereby called upon to file their respective written synopsis instead of reply/ rejoinder not exceeding *three pages*, giving a chronological list of dates and events and relevant documents, if any, along with duly highlighted judgments setting out the propositions of law therein, they wish to rely upon within a period of *four weeks*.

17. Let the latest Nominal Roll of the appellant be also requisitioned from the concerned Jail Superintendent within the aforesaid period of *four weeks*.
