1. The hearing has been conducted through Video Conferencing.

Crl.M.A.No.3559/2021

2. By this application, appellant / applicant seeks delay condonation of 8 days in filing the appeal.

3. In view of the reasons so explained, the delay of 8 days in filing the appeal stands condoned.

4. The application stands disposed of.

Crl.M.A.No.3558/2021

5. Exemption allowed, subject to all just exceptions.

6. The application stands disposed of.

CRL.A. 110/2021

7. Per judgment dated 20.12.2021 passed by the learned Trial Court in Session's Case No.379/2017 arising out of the FIR No.1636/2015 under Section 308/34 IPC registered at police station Neb Sarai, the appellant has been convicted under Section 149 and 308 read with Section 149 IPC. Per



order on sentence dated 08.01.2021, the appellant was sentenced to RI for 1 year and 6 months each with fine of Rs.15,000/-. Both the sentences to run concurrently. Fine has already been deposited. The benefit of Section 428 Cr P C was also extended.

8. Admit.

9. List in due course along with Crl.Appeal No.108/2021 as per its own turn.

10. TCR be requisitioned and tagged with the appeal.

Crl.M.(Bail).No.240/2021

11. By this application, the appellant /petitioner seeks regular suspension of sentence and bail during the pendency of appeal.

12. Per order dated 08.01.2021 on the application of appellant, the sentence was suspended for two months on furnishing the bail bond/surety bond in the sum of Rs.25,000/- by the learned Trial Court.

13. Issue notice. Learned APP accepts notice and seeks to file status report. As sought, status report be filed before the next date of hearing with an advance copy thereof to the learned counsel for petitioner through email.

14. The latest nominal roll of petitioner be also requisitioned from the Jail Superintendent. Both the documents be placed on record as well.

15. List on 15.07.2021 and in the meanwhile, the interim bail so granted by the learned Trial Court per order dated 08.01.2021 stands extended on same terms and conditions.
